33	adult-oriented businesses, is amended to add additional subdivisions to re

35	(26) "Drag performance" means a performance:	
36	(A) In which one (1) or more performers:	

1	(i) Exhibits a gender identity that is different
2	from the performer's gender assigned at birth using clothing, makeup, or
3	other accessories that are traditionally worn by members of and are meant to
4	exaggerate the gender identity of the performer's opposite sex; and
5	(ii) Sings, lip-synchs, dances, or otherwise
6	performs before an audience of at least two (2) persons for entertainment,
7	whether performed for payment or not; and
8	(B) That is intended to appeal to the prurient interest;
9	<u>and</u>
10	(27) "Minor" means an individual who is less than eighteen (18)
11	years of age.

13	SECTION 3. Arkansas Code § 14-1-303, concerning the location of adult
14	oriented businesses, is amended to add an additional subsection to read as
15	follows:
16	(d) An adult-oriented business shall not be located:
17	(1) On public property; or
18	(2) Where a minor can view what the adult-oriented business is
19	otherwise offering to the public that qualifies it as an adult-oriented
20	business.
