NOTICE RECORD OF REPORT September 19, 2016

BE IT KNOWN:

Shaddox Cemetery Association (SCA) declares and alleges that the BNR/NPS on September 12 and 13, 2016 engaged in the intentional destruction, theft, and removal/holding of our Shaddox Cemetery fence onto federal territory at the Pruitt maintenance shop. That fence constructed in August 2009 of heavy iron pipe for the purpose of resisting further elk damage to the ground and gravestones, exceeded 1,400 feet in length at a total cost of material and construction exceeding \$20,000. NPS/BNR destroyed and stole more than 1,100 feet of that fence, some of which was on ground that BNR/NPS has acknowledged was on Shaddox Cemetery property. Because that fence was very visibly posted with documentation and warnings against its removal, and NPS/BNR failed to honor the official senatorial request of Senator Boozman to provide written legal analysis of the minor boundary revision option as provided by law, and for miltiple other offenses of BNR against Shaddox cemetery, therefore SCA submits this RECORD OF REPORT that Buffalo National River National Park Service has committed crimes including, but not limited to those listed below:

- 1. Unauthorized entry and attempted technological ground penetrating radar desecration of the Shaddox cemetery.
- 2. Criminal concealment of land patent document in chain of title abstracts.
- 3. Violation of BNR enabling legislation which provided for "minor boundary revision" settlement of the purported matter—coupled with NPS' refusal to grant official senatorial request for written legal analysis of the SCA proposal of "minor boundary revision".
- 4. Criminal and malicious destruction of private property.
- 5. Criminal theft and unlawful holding of stolen private property.
- 6. Criminal trespass.

QUESTION:

Were the above named allegations performed with the complicity of officials who had previously intervened for Shaddox Cemetery in BNR/NPS actions against Shaddox Cemetery, but when those officials had recently been repeatedly notified of the recent NPS threats, in the end did nothing to prevent this most recent act of terroristic malice toward the Shaddox Cemetery, were they by their inaction guilty of failure to fulfill their oaths of office?

BE IT FURTHER KNOWN:

DOI/NPS/BNR nor any government agency cooperating with the same has permission to ever be on Shaddox Cemetery private property at any time for any purpose—specifically not for the construction of a fence of any kind, nor for any technical purpose such as ground penetrating radar. Shaddox Cemetery Association will rebuild our own fence at our own expnse in our own chosen way and chosen time—with no assistance, nor agreement, nor contracting with NPS at all.

Be it perpetually known to all present and future representatives and members of Shaddox Cemetery Association that Shaddox Cemetery Association shall never enter into a special use permit nor any coordinating project of any kind with NPS/BNR. In reporting of this matter, Shaddox Cemetery Association hereby asserts that our constitutional elected government officials are responsible in their official capacities to take the necessary steps to recover monetary damages from BNR/NPS to present to SCA for replacement of our fence that was stolen and destroyed by BNR/NPS.

And further, Shaddox Cemetery Association shall perpetually assert our constitutional and statutory and ordained right of access to the Shaddox Cemetery at all times.

It is so declared by Shaddox Cemetery Association in the Name of and by the Power of the Almighty God Whose we are and to Whom we appeal.
